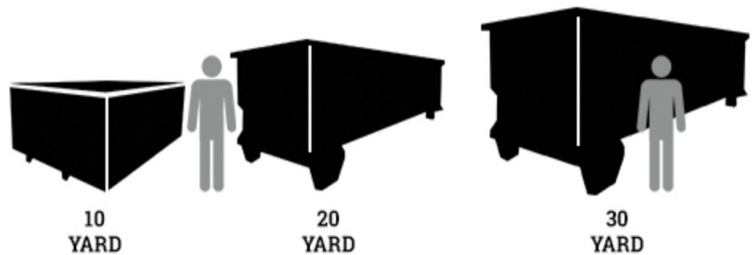

# Drop Box & Compactor Regulations

1. **Customer is responsible for all material** that is placed in the container. Only acceptable materials may be placed in the container. Acceptable material includes municipal solid waste, construction and demolition waste.
  - a. **PROHIBITED ITEMS:**
    - i. Electronic Waste (TV's, desktops, laptops, monitors, printers, keyboards, mice)
    - ii. Liquid Waste (if it passes through a paint filter, it's liquid)
    - iii. Hazardous Waste as defined in ORS 466.005 (including paint, pesticides, herbicides, asbestos, batteries, etc.)
    - iv. Infectious medical, or radioactive waste
    - v. Tires or large appliances (can be accepted if pre-arranged)
  - b. **Prohibited items found in the container will result in charges** of \$25 or more per item for disposal, plus another \$25 per item for removal.
2. **ASBESTOS CONTAINING MATERIAL:**
  - a. Oregon DEQ regulates the handling, removal, and disposal of Asbestos Containing Material (ACM), to protect public health and the environment.
  - b. **All commercial buildings** regardless of construction date, **and residential buildings constructed before Jan. 1, 2004, must have an asbestos survey** conducted by an accredited inspector prior to any demolition activities.
  - c. Any material placed in the container that may be considered suspect for ACM, including but not limited to flooring, sheetrock, duct work, roofing material, plaster, popcorn ceiling, or anything else that looks like it came from a remodel or demolition **must be accompanied by a signed Waste Acceptance Form.**
  - d. **The hauler and/or disposal site may refuse to haul the container** or process the material until the customer can provide documentation proving the load does not include ACM.
  - e. **If ACM is discovered in any load or container, the customer will be charged** for any and all cleanup costs resulting from processing the ACM.

3. **Customer is responsible for the weight** of the container. See weight limits above. Heavy or dense materials such as dirt, concrete, and roofing shingles will overload the box if loaded to water-level. Please consult our team! We are ready to help you estimate an appropriate load. Overloaded boxes will not be serviced until the weight is acceptable.
4. **All material must fit completely inside** the container. The box may not be loaded above water-level so that the box can be tarped for transport. Overloaded boxes will not be serviced until they are water-level.

5. **Thompsons is not responsible for any damage** caused to property due to placement of the container when directed by the customer or company agent.
6. **Boxes may not be moved** once they are placed during delivery, except by Thompsons. If you would like the box to be moved, please call our office to schedule.
7. **Customer is responsible for any damage** to the container other than normal wear and tear. Customer agrees to pay for any damage to the container. Repair prices will be determined by 3rd party estimate.
8. If the container is inaccessible due to being **blocked** or other reason, customer will be **assessed a haul fee**, and the service will need to be rescheduled.
9. **Containers need to be emptied at least every seven days.** After seven days without a service, a **daily rental charge** will be assessed. See page 1 for rates.

# CONSTRUCTION AND DEMOLITION WASTE ACCEPTANCE FORM

*To protect the health and safety of our employees and customers, construction, remodeling and demolition waste brought to the Agate Beach Transfer Station is screened before, during, and after unloading, for materials that may contain asbestos. This form is required for all such loads of waste that contain construction and demolition waste.*

**Analytical test results are required for the following products commonly known to contain asbestos:**

- **Interior walls and ceilings:** acoustical tiles, glue dots, plaster, and textured surfaces
- **Exterior walls:** cement siding, stucco
- **Flooring:** vinyl tiles, sheet vinyl, some mastic adhesives
- **Insulation/fireproofing:** block, boiler, spray-applied, vermiculite, monokote, sink undercoating, thermal system insulation (fiberglass, cellulose, and mineral wool are exempt)
- **Gaskets:** furnace, mechanical, boiler, wood stove (automotive gaskets are exempt)
- **Heating:** white paper or seam tape on ducts, air-duct cement and insulation
- **Roofing materials:** tar paper, felt, silver/white roofing paint, Nicolite paper  
Note: three tab composition shingles do not contain asbestos
- **Fire doors, fire/kiln brick and fireproofing**
- **Various compounds:** window glazing, adhesives, caulks, patching, mastics, vapor barrier products (plastic or synthetic materials such as Tyvek are exempt)
- **Electrical:** switch gear, circuit boxes and fuse panels; wiring with cloth insulation (Romex wiring is exempt)

## INSTRUCTIONS FOR FILLING OUT THIS FORM

- This form is required for all loads containing construction, demolition, or renovation material.
- This form should be completed by the person responsible for and knowledgeable about the contents of the load.
- For multiple-load projects, copies of this form will be accepted, but the contents of the load must match the description of the waste materials on the form.

All parties involved (generator, contractor, and hauler) may be held responsible for the abatement of positive (greater than one percent asbestos by weight) asbestos-containing materials unloaded at SCT's transfer stations, including but not limited to the costs for testing, a licensed abatement contractor, fines, and administration.

# CONSTRUCTION AND DEMOLITION WASTE ACCEPTANCE FORM

1. When did the construction, demolition, or renovation materials originate from the structure or RV?
  - Was the material constructed after Jan 1, 2004 (skip to #3, you do not need an asbestos survey)
  - Is the material bare wood, metal, glass, or three tab composition shingles with no tar paper. (skip to #3, you do not need an asbestos survey)
  - Was the material constructed before Jan 1, 2004 or Commercial Building (proceed to #2)
2. Was an asbestos survey conducted?
  - Yes-if yes, attach the survey. A survey was conducted, if there was any asbestos containing materials (ACM), they were identified in the survey, and submittal of this form is my statement that the ACM materials are not present in this load. Proceed to #4.
  - No -**if no, a survey has to be conducted on construction, demolition, or renovation debris constructed before 1/1/2004. We are sorry, we cannot accept your load without a survey.**
3. Material was constructed after Jan 1, 2004, therefore no survey is required, and I verify there is no asbestos containing material present in this load.
